#### 1a. Psychological First Aid\*

#### 1b. Chemical, Biological, Radiological, and Nuclear Awareness\*

This session will provide participants a chance to investigate a chemical, biological, radiological, and nuclear attack on a civilian population. A case study will provide historical context of the attack and how the population responded to the attack. We will review each of the responses and compare them to available capabilities in New Hampshire.

This session will provide participants with a chance to learn about the Strategic National Stockpile (SNS) and each of the four different SNS packages. In an emergency, these packages would provide the state with several different response options and capabilities. Session will discuss these differences and review New Hampshire's CHEMPACK program, including how the CHEMPACKs would deploy in an emergency.

- Understand the differences between each SNS package.
- Describe NH's CHEMPACK program and deployment procedures.

#### 2d. Can you help me find my family?

NH General Population Shelters provide mass care services such as meals, temporary housing, and reunification for individuals directly impacted by disaster. Recent national disasters have resulted in improvements to American Red Cross (ARC) shelter operations and forms. One recent ARC update is the January 2017 release of Reunification Standards and Procedures. This document complements the current draft of the State of New Hampshire's Multi-Agency Reunification Services Plan. In this session, participants will learn about reunification services and procedures used in general population shelters.

Following this session, participants will be able to:

- Define reunification services.
- Describe standards and procedures for child/family reunification.
- Utilize the reunification process for shelter clients.

# **2e. Lessons Learned from My Own Emergency: How We Can Better Prepare Citizens for Emergencies of All Sizes**

This session will describe the many preparedness resources available to public safety agencies and organizations for the purpose of training citizens on personal emergency planning and basic emergency skills. In addition, the presenter will provide a background of a personal emergency that occurred to his family in 2017, some of the lessons he learned, and how he was able to adapt his agency's citizen training programs to include information on actions citizens can take until help arrives and how to better prepare themselves for an emergency displacing them from their home.

- Describe and utilize techniques to deal with an emergency displacing someone from their home.
- Understand some of the actions that can take place at an emergency while waiting for first responders.

# 2g. Dementia and Disaster Intervention: Understand, Approach & Respond\*

Dementia currently impacts over 140,000 citizens of MA and NH. Because dementia affects far more than memory alone, a specialized approach to disaster and emergency response is critical. This session will explore information about dementia and its symptoms, how the disease impacts the ability to communicate, and the related behavior changes that arise, particularly during times of crisis or disaster. Participants will learn dementia-specific techniques for successful and sensitive disaster response interventions with those living with various forms of dementia.

- Recognize dementia and its symptoms.
- Describe how dementia impacts communication and behavior.
- Utilize dementia-specific disaster response techniques.

# 3a. Civilian Response to Active Shooter Events\*

Civilian Response to Active Shooter Events (CRASE) is about survival. Failure to act quickly during an active shooter event can leave you in a position to be injured or killed. The faster you decide to take action, the more likely you can save your life and the lives of those around you. CRASE Training will help you to more quickly decide to take action by providing a strategy that develops your situational awareness, mental planning, and a common sense approach to surviving an active shooter event. Awareness and planning are the keys to survival.

Following this session, participants will be able to:

- Become situationally aware of their surroundings to maximize survivorship in emergency situations.
- Use Avoid-Deny-Defend (ADD) tactics in their survivorship actions.
- Apply survivorship lessons learned from the past 15 years of active shooter events to organizational and personal safety protocols.

#### 3b. NH's Heroin Epidemic\*

This session will provide an overview of New Hampshire's current opioid crisis and the state's response, including a demonstration of how to administer naloxone.

- Provide an overview of the state's response, including prevention, intervention, treatment, and recovery.
- Identify signs and symptoms of an opioid overdose.
- Administer Naloxone.

#### 3c. Radiological Concepts\*

This is a mid-level radiological concepts session that not only describes the primary ionizing radiations that can be encountered, but also provides additional information on why certain types of radiation are considered only an internal hazard.

- Describe levels of radiation that become a serious hazard.

#### 3e. National Weather Service Weather Spotter Training

This session will feature an introduction to different types of severe weather (thunderstorms, flash flooding, winter storms) and the impact of these storms in northern New England. The session will also inform participants on how to report severe weather and its effects to the National Weather Service. Everyone who attends will become a trained spotter and be issued an NWS spotter ID.

- Describe severe weather in New England.
- Identify important features of storms.
- Properly measure snowfall.
- Report severe weather and impacts to the National Weather Service.

You may encounter situations in which debris needs to be removed to free victims of a damaged building they are trapped in. This session will be a hands-on interactive demonstration of the safe use of leveraging and cribbing such debris as a means of extracting a person from the damaged site.

- Maintain rescuer safety.
- Triage in a lightly or moderately damaged building.
- Safely evacuate victims from a damaged building using items that may be available.
